

**AGREEMENT NO. GCA 5831
AMENDMENT NO. 1**

This AMENDMENT NO. 1 is made and entered into between the Washington State Department of Transportation, hereinafter the "STATE," and the Confederated Tribes of the Umatilla Indian Reservation hereinafter the "UMATILLA TRIBE," also collectively the "PARTIES" and individually the "PARTY."

WHEREAS, the PARTIES hereto entered into the original Agreement Numbered GCA 5831 on August 28, 2008, which provides for the UMATILLA TRIBE to provide an Oral History Compilation of the UMATILLA TRIBE, and

WHEREAS, it is deemed desirable to amend the original agreement by increasing the total amount authorized and extend the expiration date to complete the work covered under the original Agreement.

NOW, THEREFORE, in consideration of the terms, conditions, covenants, and performances contained herein, or attached and made a part hereof,

IT IS MUTUALLY AGREED AS FOLLOWS:

1. It is mutually agreed between the PARTIES that the UMATILLA TRIBE continue with the work covered by the original Agreement. The Expiration Date in the original agreement is hereby extended to December 31, 2009.
2. The total amount authorized in the original agreement is hereby increased by \$40.80 bringing the total amount authorized to \$21,037.90.
3. Exhibit B of the original Agreement is hereby replaced with the attached Exhibit B-1.
4. All other terms and conditions of the original Agreement shall remain in full force and effect except as modified by this AMENDMENT NO. 1.




